This information can include: ◆ Social Security number ◆ Payment history ◆ Income ◆ Transaction or loss history ◆ Account balances ◆ Employment information When you are no longer our customer, we continue to share your information as described in this notice. | | |
| How? | All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons North Shore Bank chooses to share; and whether you can limit this sharing. | | |

These measures include computer safeguards and secured files and buildings. North Shore Bank has established standards and practices to ensure compliance with the provisions of M.G.L. c.93H relative to the safeguarding of personal information contained in both paper and electronic records for residents of the Commonwealth of Massachusetts and recognizes similar privacy standards in affiliated states for which their customers reside. | |
| How does North Shore Bank collect my personal information? | We collect your personal information, for example, when you ◆ Open an account ◆ Deposit money ◆ Apply for a loan We also collect your personal information from others, such as credit bureaus, affiliates, or other companies. | |
| Why can't I limit all sharing? | Federal law gives you the right to limit only ◆ sharing for affiliates' everyday business purposes - information about your creditworthiness ◆ affiliates from using your information to market to you ◆ sharing for nonaffiliates to market to you State laws and individual companies may give you additional rights to limit sharing. | Definitions | | |
| Affiliates | Companies related by common ownership or control. They can be financial and non-financial companies. • North Shore Bank does not share with our affiliates. | |
| Nonaffiliates | Companies not related by common ownership or control. They can be financial and non-financial companies. • North Shore Bank does not share with nonaffiliates so they can market to you. | |
| Joint Marketing | A formal agreement between nonaffiliated financial companies that together market financial products or services to you. • Our joint marketing partners include investment companies. | |

For Massachusetts, Mississippi and New Jersey Customers. We will not share personal information from deposit or share relationships with nonaffiliates either for them to market to you or for joint marketing - without your authorization.
